#### DESCRIPTION

SikaPlast<sup>®</sup>-163 is a 3<sup>rd</sup> generation polymer based high performance superplasticizer for producing soft consistency concrete.

SikaPlast®-163 meets the requirements of ASTM C 494 type D & G.

SikaPlast<sup>®</sup>-163 conforms to Type G when used at 0.8–1.0% dosage, depending on cement type used.

#### USES

SikaPlast<sup>®</sup>-163 is mainly suitable for the manufacture of concrete for RMC plants and site batch concrete. SikaPlast<sup>®</sup>-163 is used for the following types of concrete:

- High strength bored piles;
- Bridges and cantilever;
- Ground and suspended slabs;
- Columns and walls.

#### **CHARACTERISTICS / ADVANTAGES**

SikaPlast<sup>®</sup>-163 combines different modes of actions. By adsorption on the surface of the fines and keeping them apart while the hydration is in progress, Sika-Plast<sup>®</sup>-163 effects the following concrete properties:

- Long slump keeping and high water reduction;
- High flowability (considerably reduced placing and compacting work);
- Faster evolution of early strength development;
- Workability can be maintained up to 3–6 hours (still depends on admixture dosage, cement type, temperature);
- Improved creep and shrinkage resistance characteristics;
- When used at higher dosages, SikaPlast<sup>®</sup>-163 can give extended working time.

SikaPlast<sup>®</sup>-163 contains neither chlorides nor other corrosion inducing substances and can therefore be used without any restrictions for reinforced concrete structures.

Concreting guidance	With the use of SikaPlast®-163, concrete of highest quality is being pro- duced, however state of the art concrete technology, such as mixing, pla- cing vibrating and curing must be respected and applied.
Specific advice	<ul> <li>Addition/Mixing: SikaPlast®-163 is added to the gauging water prior to its addition to the dry mix or added separately to the wetted concrete mix. For optimum utilization of the ultra-high range water reducer we recommend a minimum wet mixing time of 60 seconds.</li> <li>When adding the balance of the batching water to adjust concrete consistency this should be done after a minimum of 2/3 of the wet mixing time to avoid surplus water in the concrete.</li> <li>Curing: Effective measures for concrete curing must be followed.</li> </ul>

Recommended dosage	0.5–2 L per 100 kg of cement Typical 0.8 to 1.2 L / 100 kg
Compatibility	SikaPlast <sup>®</sup> -163 may be combined with all Sikament, Sika <sup>®</sup> Aer, Sika <sup>®</sup> Pump, Sikacrete <sup>®</sup> PP-1 products, but must be added separately to the mix and not pre-mixed prior its addition. SikaPlast <sup>®</sup> -163 is compatible with all Portland cement types.
