#### DESCRIPTION

Placing and finishing requirements are facilitated because this admixture retards setting time

Sika<sup>®</sup>Plastiment<sup>®</sup>-222 R MM meets ASTM C494 Type B (retarding) and Type D (water reducing & retarding) admixture.

It will not initiate or promote corrosion of reinforcing steel in concrete and does not contain intentionally added calcium chloride or chloride-based ingredients

#### USES

Sika<sup>®</sup>Plastiment<sup>®</sup>-222 R MM is recommended for use in all types of concrete where retardation of set and improved performance are desired eg. Plain, reinforced, precast or prestressed concrete especially when placing by pump and enhanced finishing is desired. When used in conjunction with other admixtures, each admixture must be dispensed separately into the mix.
